Appellant present in person. Rana Sajjad Deputy Secretary, Ministry of Defence appeared on behalf of the public body.

2. Written reply has been furnished by the public body/Ministry of Defence, submitting that a detailed probe was conducted based on the sketchy information provided by the appellant, and it has been found that no officer named Col. Jibrán, Inspector Ali, or Insp Hafeez is serving in the said organization.
3. The background of this appeal is that the appellant filed an appeal to the Federal Secretary, Ministry of Defence, alleging that the above-named persons, posing as officers of the ISI, are creating harassment against him. He made request to the Defence Secretary to inquire into the matter and provide him with a copy of the inquiry report, which was not provided, whereupon this appeal was filed.
4. In view of the written reply furnished by the public body, probe was conducted, and it was found that the persons named in the complaint of the appellant are not serving in the ISI. In light of the above, when the alleged persons are not serving in the ISI, as per the reply of the public body, the required information cannot be obtained and shared with the appellant.
5. The appeal stands disposed of. Copy of the order be sent to both the parties.
