Muhammad Faheem Abbas, Executive Engineer, Pak PWD appeared on behalf of the public body.

2. From the perusal of the record, it has been found that a copy of the notice issued to the Secretary, Ministry of Housing and Works, was sent to the address of the appellant but was returned undelivered with the report that no person by the name of the appellant resides at the given address. The delivery man also recorded in his report dated 28-11-2024 that he inquired from the surrounding inhabitants about the appellant's residence, but none confirmed his residence.
3. In addition to that, the Commission, through the registrar's office, contacted 0318-5888688, but reportedly, the appellant's cell phone was found switched off.
4. From the above-mentioned facts, the Commission is satisfied that this appeal has been filed using a false address and is not maintainable. Hence, it is dismissed.

Ms. Mehraj Tareen Advocate appeared on behalf of the public body.

2. The appellant, vide his information request dated 10-07-2024, addressed to the Chairman CDA, requested a certified copy of the reconstructed file in respect of his plot. Since the said information was not provided by the CDA hence, he filed the instant appeal.
3. Notice was issued to the public body, and it filed a written reply vide letter dated 20-11-2024. It was submitted that the plot files No. 1600, Sector I-11/2, Islamabad, are not available in the record room. Consequently, a file missing circular has been issued for reports, and a case has been referred to the Security Directorate, CDA, to investigate the matter of the missing files. Furthermore, the opponent, Mst. Mah Moeen, has submitted a status quo order from the Civil Court to stop the proceedings for the transfer of the instant plot. Additionally, a high-profile committee has been constituted under the directions of the Ministry of Interior regarding the missing plot files. The file of plot No. 1600, Sector I-11/2, Islamabad, is under reconstruction and will be intimated as and when the file is reconstructed. In view of the position explained above, the subject complaint may be considered settled.
4. It is further added that the file of the said plot was missing, an inquiry is in process, and the reconstruction process has not been finalized yet.
5. Copy of the written reply was shared with the appellant, who, vide 31-12-2024, stated that, in fact, the plot file has been reconstructed and is with Mr. Javed, Dealing Assistant DA of I-11/2, who received the file on 06-07-2022.
6. The Commission has examined the contents of the information request, the written reply furnished by the public body, and the rejoinder of the appellant. The CDA has categorically stated that, up till now, the file has not been reconstructed and is still under process. Therefore, the mere assumption of the appellant that the file is reconstructed cannot be given weight. However, if the

appellant believes that the statement of the CDA is incorrect, he may approach the concerned quarter against the same.

7. The appeal stands disposed of. Copy of the order be sent to both the parties.
