1. The public body, vide letter dated 17-09-2025, furnished a copy of the order of the Prime Minister on the appeal; however, a copy of the appeal was not furnished with the objection that it cannot be provided as it falls under Section 7(g) of the Right of Access to Information Act, 2017. Copy of the written reply along with the document furnished by the public body was shared with the applicant, but he, vide his letter dated 10-10-2025, again insisted on being provided a copy of the appeal. Written reply to the rejoinder is also furnished by the public body with a similar plea already taken.
2. The Commission has examined the contents of the information request, the written reply furnished by the public body, the rejoinder of the applicant, and the reply to the rejoinder, and found that the applicant is not the appellant in the appeal in question filed before the Prime Minister; therefore, under Section 7(g) of the Right of Access to Information Act, 2017, the said documents cannot be provided to the applicant, being record relating to the personal privacy of individuals.
