The public body vide letter dated 18-08-2025 submitted that volumes of Financial Management Allowances at Missions Abroad including the rates of Foreign and Entertainment Allowances (Chapter V) are available on the website of the Ministry of Commerce. Link of both the volumes is also provided. Copy of the same was shared with the applicant who acknowledged its receipt but vide his rejoinder dated 04-09-2025 has submitted that he visited the website and found that the manual contains the rate of financial and entertainment allowance which was allowed to staff at Pakistan Mission Abroad in 2011. Said rates are revised and a new notification of Foreign and Entertainment Allowance was issued in November 2023 as he requested in his information request.
2. The Commission has examined the contents of the information request, reply of the public body and objections of the applicant. The Ministry with responsibility furnished written reply and provided the link of the website. If the applicant believes that said information is misleading or incorrect, he may file complaint before the Commission under Section 20 of the Right of Access to Information Act, 2017. The appeal stands disposed of. Copy of the order be sent to both the parties.
