3. The Cabinet Division has submitted a revised reply, which has been compared with the information request and found to address all the queries mentioned therein.

None appeared on behalf of the public body.

1. Despite the fact that two notices dated 24-03-2025 and 18-04-2025 were sent to the Chairman of the public body for provision of record/appearance, these notices were sent through RGL No. 146097703 and 153080805 respectively.
2. The notice dated 18-04-2025 clearly states that in case of failure to attend, ex parte proceedings will be initiated against the public body.
3. The Commission feels that unnecessary delay caused due to the absence of public bodies should be avoided to meet the timeline provided for deciding the appeals.
4. In view of this, the Commission is satisfied that an ex parte order be made due to the failure of the public body to respond to the notices of the Commission.
5. The information request has been perused, which seeks very basic and important information of public importance and does not fall under any exemption provided under the Right of Access to Information Act, 2017.
6. In view of this, the appeal is decided, and the Chairman, SECP, is directed to share the information sought by the appellant within 10 days of the receipt of this order.
7. The office is directed to put up this file before the Commission to oversee the implementation status after the passage of the appropriate time limit.
