2. The public body vide letter dated 31-12-2024 informed that NADRA filed complaint to the FIA vide letter date 04-11-2024 for lodging FIR against Dr. Tahir Akram, Ex-DG NADRA for misuse of Official Authority with respect to vehicle BMW Model No. 2002 and Inquiry No. 413/2024 is under process. Therefore, under Section 16 (b)(ii) of the Right of Access to Information Act, 2017 *“the information cannot be disclosed as it may harm the detection, prevention, investigation or inquiry in a particular case”*.

3. The main purpose of the appellant was to highlight the officer who misusing a vehicle which was taken from the Director General, Intelligence and Investigation Customs against the payment of Rs. 50 Thousand. While securing the written reply from the public body the name of the said officer has come at surface and inquiry is pending with FIA about the misuse of said vehicle, therefore, the appellant shall be provided remaining particular / answer of the queries after the conclusion of the said inquiry. Copy of the letter dated has already been shared with the appellant.

4. In view of the above, no further proceedings are required; the appeal is disposed of. Copy of the order be sent to both the parties.
