Abdul Ahad Memon, PIO, EOBI present on behalf of public body.

2. The response of the public body was received by the appellant whereupon he has sent his dissatisfaction stating that:

*“There are employees from whom deductions have been made in the name of EOBI, but their records have not been submitted to EOBI by the Primer organization. EOBI is reporting the number of registered employees but the names of these employees and their respective positions in the organization have not yet been provide by EOBI. While the Right of Access to Information Act does not impose privacy restrictions, it is very clear that the names of employees and their official positions are not protected by privacy laws, and the Access to Information Act, does not impose such restriction. I would also like to bring on record that the number of employees registered with EOBI from various organization, as well as the official details of their positions have not been made publicly accessible on the website.”*

3. The dissatisfaction elements were placed before the representative of the public body who has stated as “Employees working with the statutory bodies are not covered under the EOBI Act and no contribution is taken from their such organizations.

4. The EOBI collects contributions from eligible organizations on behalf of their employees and not directly from the employees. Data about insured persons is available on website which the concerned can be accessed by the ensured organization / ensured person. He has stated that this is personal information and only concerned individual can access it by his or her CNIC number. He has further stated that the

personal information is exempted under section 7(g) of the Right of Access to Information Act, 2017.

5. The Commission has examined the information request, response of the public body, provisions of the Act and applied mind in this matter. The Commission concludes that necessary information has been provided to the appellant as required under the Act and personal information about insured employees cannot be shared.

6. In view of the above position, the appeal stands disposed. Copy of order be sent to both the parties.
