The information provided by the designated official/Public Information Officer of the public body was submitted before the Commission on the last date of hearing i.e. 31-10-2024, under his handwriting, name, designation, and appended signature along with the date. The signatory is a designated officer of the public body. The appellant, in his rejoinder dated 14-11-2024, has mentioned two points, stating that Mr. Inam Ullah could never misbehave by writing down reply on simple paper with his own hand and without any stamp of the bank. He has also alleged that the signature does not tally with the reply submitted in appeal no. 3755 before the Pakistan Information Commission (PIC).
3. The Commission has heard the representative of the public body. It has also examined the information request as well as the points raised in the rejoinder by the appellant.
4. The Commission observes that the information was provided by the designated representative of the public body on the directions of the Commission and in the appellant's presence to finalize the appeal and reduce time lag. The second point, relating to differences in signatures, is beyond the scope of the Commission as the designated official signed the response in the presence of the Commission. The question of any doubt about the signature does not arise.

Information provided by the public body was shared with the appellant vide letter dated 23-10-2024, whereupon the appellant submitted a rejoinder dated 11-11-2024. The appellant stated that the information provided under serial numbers 1 and 2 of the public body's response meets his requirements. However, regarding point No. 3 of the public body's response, the appellant contended that it does not meet the requirement and information as sought by him, stating: *"That instant para does't meet the requirement and information as sought by me i.e "Rent Deposited, received, from/to/by the contractor of "staff Welfare Canteen" for the period of i.e. 01/05/2021 to 31/01/2024." But respondent failed to reply on following lines:*

*a. Respond supplied payment detailed as "Flag B" from 01/01/2019 to 30/04/2021 and for Feb-2024 to onward which is out of context and intentionally attempted to conceal the exact dates as mentioned in the para i.e. 01/05/2021 to 31/01/2024 in my appeal.*

*b. That respondent instead to provide the payment details for the period or express answer of non payment is explaining its illegal acts and corrupt practices which is not my requirement my requirement is exact and express payments during the period mention in the appeal, hence information to the extent of para 3 does not meet the requirements and information as sought in the instant appeal."*

2. The contents of the information request, the response of the public body, and the appellant's rejoinder have been examined by the Commission. It has been observed that, vide para 1(c) of the information request, the appellant sought details of awards and contracts awarded/executed in respect of the staff welfare canteen from 01-01-2019 to 31-03-2024. The issue raised by the appellant in his rejoinder does not match his information request and, as such, is beyond the scope of the information sought by him.
3. The response of the public body is quite comprehensive and matches the specific question of the information request. In view of the above,

no further proceedings are required. The appeal stands disposed of.
