The Commission has examined the contents of the information request whereby the applicant has required copy of the tender notices announced/published about the tenders of the audits of different housing societies, links of the tender notices published on the PPRA website and link of the bidder/firm participated in the said tenders.

2. It is noted that the information has been required from PPRA in respect of tenders issued by the Cooperative Housing Society Islamabad. Said societies are not public bodies and are private entities and do not fall under the definition of the public body. Moreover, announcement/publication of the tenders in respect of the audits of the said societies is not required to be published on the PPRA website and PPRA has no concern with the subject matter. In view of above, the appeal is not maintainable hence dismissed. Copy of the order be sent to both the parties.
