The public body, on notice of the Commission, filed a written reply vide letter dated 07-02-2025 and pleaded exemption of the said report from disclosure under Section 7 of the Right of Access to Information Act, 2017. The Commission decided the appeal vide order dated 07-05-2025 after considering the plea of the public body. The said plea was turned down, and the public body was directed to furnish a certified copy of the required audit report within 10 days.

3. In compliance with the order of the Commission, the public body furnished a certified copy of the required audit report, which was shared with the applicant vide letter dated 02-10-2025. The applicant acknowledged receipt of the said report but objected that it is not the document required by him, and he again repeated the same complaint. The Commission has examined the information request, wherein the applicant required a copy of the audit report of the Cantonment Board Quetta, and the said report has been provided by the public body; therefore, the objection of the applicant is turned down. No further proceedings are required. The appeal stands disposed of. Copy of the order be sent to both the parties.
