None appeared on behalf of the public body. However, a written reply and rejoinder of the applicant have been received through email of even date. The public body, vide letter dated 17-02-2025, has furnished the information in reply to the notice served upon it after the institution of the appeal, and said information was shared with the applicant, who filed rejoinder over the said shared information. Copy of the said rejoinder was sent to the public body, and its reply has been received through letter dated 25-07-2025. Again, said reply was shared with the applicant, who has again filed a rejoinder raising certain objections; however, it has been informed that the applicant is satisfied in respect of query No. 2, 4, and 13.

2. The Commission has examined the information request, memo of appeal, written replies furnished by the public body, and rejoinder of the applicant and reply to the same. All the points were taken one by one and compared with the information request and written reply furnished by the public body. The Commission has found that objective replies have been given by the public body in respect of the information request and also furnished the record available with it. However, some record was not available with the public body, with the submission that it has been disposed of following the SOP, and the applicant has submitted that said excuse is not acceptable and is a false pretext. In this regard, the Commission observes that if the applicant believes that the stance of the public body or any information furnished by the public body is incorrect, he may file a complaint before the Commission under Section 20(d) of the Right of Access to Information Act, 2017. The appeal stands disposed of. Copy of the order be sent to both the parties.

The public body, vide letter dated 30-07-2025, furnished the required information containing four pages, and list of all the establishments along with their registration and period have been mentioned there in. The applicant was provided with the said information, who acknowledged its receipt but filed an objection with the remarks that the said list does not contain the list of establishments that were registered after the creation of District Narowal and later closed.

2. The objection of the applicant was shared with the representative of the public body, who submitted that the information already furnished and shared with the applicant includes the names of all the establishments registered with the EOBI, including the list of establishments registered after creation of District Narowal, as required in the information request of the applicant.

2. The representative of the public body has furnished written reply stating that information required by the applicants comprises of 800 and the public body is ready to furnish the same subject to the payment of photocopying charges at the rate of Rs. 20 per page.

Since the public body is ready to provide the required information subject to the payment of photocopying charges and according to Regulation 3 of the Access to Information (Fee) Regulations, 2023 of the Commission, the public body is bound to share with the applicant the required information containing 20 pages free of cost and for remaining documents charges per copy fixed by the Commission are Rs. 7/- per page.
