Muhammad Saleh Narejo, Director, Prime Minister's Inspection Commission appeared on behalf of the public body.

1. The public body furnished most of the information except the information sought at serial 3 and 5 of the information request. The information furnished by the public body was shared with the applicant who acknowledged its receipt but raised the objection that information requested at serial 3 and 5 is not furnished, which is in respect of inspection and inquiry reports conducted during a specific period. The public body furnished reply to the rejoinder, the same be shared with the applicant.

2. It is also mentioned in the letter dated 26-05-2025 by the Prime Minister's Inspection Commission that the said information will only be shared after authorization of the Prime Minister, and request has been made to the Prime Minister for deciding its authorization, and yet the decision of the Prime Minister has not been received.

3. In view of the above, when the decision of the Prime Minister for sharing the information cited at serial 3 and 5 of the information request is pending, the public body cannot be ordered to share the same with the applicant as the inquiry/inspection would be considered final after approval of the head of the public body, who is the Prime Minister. No further proceedings are required. The appeal stands disposed of. Copy of the order be sent to both the parties.
