Zia Ul Islam, Deputy Director (E&M), CDA appeared on behalf of the public body.

1. The representative of the public body states that the information required by the applicant is not wholly related to his directorate. It has been noted with concern that the information request addressed to the Chairman, CDA is not being responded to wholly, causing delay in disposal. It is the obligation of the Chairman, CDA to consolidate information from different directorates and present it before the Commission, as he is answerable before the Commission in his official capacity. Let notice be issued to the Chairman, CDA to provide comprehensive response to the information request, signed either by himself or one responsible officer of the public body. It may be mentioned that the response should be complete in all respects to save time and to facilitate disposal of the appeal.
