Prizada Shamsher Ali, Accounts Officer appeared on behalf of the public body.

2. Response provided by the public body was shared with the appellant who has sent a rejoinder regarding Serial No. 3 and 4 of the information request. The information request, response of the public body and rejoinder have been examined by the Commission. The representative of the public body has also been heard. In response to Serial No. 3 of the information request, he stated that only one-time deposit was made in the joint account of DC Kohat on 15-03-2024. He also stated no other credit has been made before that.

3. In response to Serial No. 4 he clarified that the production bonus is paid after the start of commercial production in the field. He stated that commercial production started in 2013 and details of the deposit of bonus in the account of DC Kohat have been given in the response. No other deposit has been made except in 2013, 2015 and 2019.

4. In view of this examination and analysis the response provided by the public body meets with the information request of the appellant. No further proceedings are required. The appeal stands disposed of. Copy of the order be sent to both the parties.

Sehrish Mushtaq, Litigation Officer present on behalf of the public body. This is an old case and the file was not put up before the Commission on the date of hearing of 02-01-2024 as mentioned in the order dated 12-12-2023. The Commission expresses its anguish over the situation. The Assistant Director put up the file with a statement that it was in a locked room. To move things forward the commission ordered that this be fixed for hearing.

2. The representative of the public body has highlighted the sensitivity of the matter attached to this information request and has drawn the attention of the Commission to the response of the public body dated 08-06-22 whereby exemption has been invoked under Section 16 (1) ,(b), ( i), (v), (c) and (f) of the Right of Access to Information Act, 2017. The information request has been pursued, response of the public body has been seen and the Commission has also examined the law with particular reference to the provisions highlighted by the representative of the public body. The Commission is of the view that the public body has rightfully invoked the exemption provisions of the Act keeping in view the sensitive nature of the matter.

3. The exemptions provided under the law have a logic and to cater for such situations. The plea of the public body is sustained and the appeal is disposed of in the terms that this information cannot be shared with the appellant for the reasons mentioned above. The appeal stands disposed of. Copy of the order be sent to both the parties.
