2. The learned advocates argued that the Director General, Military Land and Cantonment Department was not directly responsible for the information sought by the applicants and that the show cause notice issued to him may be responded to under the signature of the Additional Director. They were informed that the reply to a show cause notice must come from the person to whom the notice has been issued.

3. However, upon examining the file, the Commission observed an interesting fact: there was no show cause notice issued to him available on record. The term “show cause notice” appears in the order sheets, but in fact, it was only a final notice dated May 07, 2025, issued under RGL No. 153081597, stating that in case of non-compliance, action under Section 20(1)(f) of the Right of Access to Information Act, 2017 would be initiated.

4. In view of this fact, the Commission cannot insist on compliance with something that appears to have resulted from an inadvertent error. The information provided by the public body has already been shared with the applicant vide letter No. 15426932, and no response has been received.

5. Accordingly, there is no need for any reply to a show cause notice which was never issued to the Director General, ML&CD. The appeal stands disposed of. A copy of order shall be sent to both the parties.
