A. APPEAL.

- 1. Mr. Pervez Said, appellant filed an application to the Secretary Ministry of Communications under the Right of Access to Information Act 2017, for the provision of following information:
 - i. "What is the reasoning behind the particular stretch of the Lahore-Sialkot Motorway being unpoliced at the time of the unfortunate incident in question on 9.9.2020?
 - ii. What are the reasons for no member of Motorway Police coming to the help and rescue of the victim and her children in their hour of need?
 - iii. What is the reasoning for non-provision of sufficient resources on the Lahore-Sialkot Motorway whereby Motorway Police or other Government personnel are not available for the protection and safety of road users in that area?
 - iv. What measures does the Ministry propose to take to ensure that the Motorway Police is available at all times to all persons along the Motorway in order to effectively police the area?
- 2. The requested information was not provided to the appellant within the stipulated period therefore feeling aggrieved the appellant filed his appeal before the Pakistan Information Commission for the provision of the above mentioned request.

B. PROCEEDINGS:

3. On the intervention of the Commission the National Highway Authority filed para wise reply which is as under:-

4. The appellant through his letter dated 28.01.2020, addressed to the Commission conveyed his dissatisfaction with the information shared by the NHA. The relevant part is reproduced as under;

"Notwithstanding the fact that the answers to our questions ostensibly answered by NHA are not satisfactory, even otherwise, we did not submit our application to the NHA but to the Ministry of Communication which is duty-bound to respond to our RTI under the Right of Access to Information Act, 2017".

5. Keeping in view the divergent pleadings, the appeal was fixed before the Commission on 24.02.2021 and both the parties were informed accordingly vide notices dated 04.02.2021. On 24.2.2021, Miss Asima Naqvi, DSP the representative of the public body appeared and provided the following information which is shared with the appellant.

B. COMMISSION'S VIEW.

- 6. The reading of the request depicts that the appellant has asked for the provision of information vis-à-vis the deployment of Motorway Police on Lahore-Sialkot Section. He further desires to know the reasons for not rescuing the victim and children of the unfortunate incident of 9.2.2020 by the Motorway Police and the steps and measures taken in this behalf for the protection and safety of the public. The Commission after going through the request and the reply is of the considered view that all the queries has been responded and addressed by the Ministry of Communication and NH&MP.
- 7. The appellant has not asked for the provision of any particular document or record specifically in his request rather has desired to know the reasons and the application is based on queries. Reasons generally are oral information whereas the Act defines the "information" as information based on record. The Commission expects the applicants desirous of information to be more particular and precise in the drafting of their requests.
- 8. Ministry of Communications is the central policy making body and administrative authority in roads infrastructure, road transportation and policing on National Highways & Motorways. National Highway Authority and National Highways & Motorway Police are the organizations of the ministry. The reply submitted by the allied department or organization on the direction of the ministry is considered as reply by the ministry. The objection of the appellant against the ministry for not responding is uncalled for and not sustainable. However the public bodies are expected to respond and process the applications as required under section 13 within the stipulated frame of time provided in the Act.
- 9. It has been noticed by the Commission that designated officer as required under section 9 of the Act has not been notified by the respondent public body. In the absence of the designated officer the principal officer is treated as the designated officer.
- 10. Section 5 provides the category of record that has been mandated to be published including uploading over the internet to ensure its accessibility, within six months of the commencement of the Act.

C. ORDER.

11. The appeal does not call for any further interference by the Commission; however the Secretary, Ministry of Communication is directed to make arrangements for the implementation of sections 5 & 9 of the Act, under intimation to the Commission by 19.4.2021.
